5 completely and truthfully testify as to the statements contained herein.

6 2. Central Valley Neighborhood Harvest is a nonprofit volunteer organization whose
7 mission is to prevent food insecurity and promote food justice, promote youth agriculture and life
8 skills, and promote sustainable use of urban resources.

9 3. I am founder and CEO of Central Valley Neighborhood Harvest, and am also a
10 master gardener.

11 4. I also serve as planning commissioner for District 5 in the City of Stockton.

12 5. In addition, I am a charter member for the City of Stockton Mayor's task force on
13 persons with disabilities.

14 6. As founder and CEO of Central Valley Neighborhood Harvest, my business is
15 committed to harvesting healthy and affordable food for Stockton area's poor, senior and disabled
16 populations.

17 7. Central Valley Neighborhood Harvest has received nine acres from private donors in
18 the southeast section of Stockton. We currently farm two acres and irrigate with both well water and
19 city water.

20 8. Central Valley Neighborhood Harvest also operates two school gardens and six urban
21 community garden sites.
