Paul Rogers contacted Jim with questions about the SWP tax, and he also had questions regarding District payments for BDCP planning costs and our share of the \$1.2 Billion preconstruction financing costs. I called him today (7/22/14) and provided the following information:

## Planning costs:

- Direct payments = \$9 Million (\$3.5 M State and \$5.5 M through SLDMWA)
- Advanced O&M payments of \$4.2 M that will be credited to the District.

District's share of \$1.2 Billion in preconstruction financing

- The agreements and financing structure are still in development, so we don't have a specific dollar amount
- We expect the District's share to be between 7 and 10 percent of the cost.
